Assumption of Risk and Release

1. I have chosen to participate in this activity. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me or in my control, as a result of being engaged in this activity, whether caused by the negligence of NU or otherwise.

It is my express intent that this Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representatives, if I am deceased, and shall be deemed as a release, waiver, discharge, and covenant not to sue NU. I hereby further agree that this Agreement shall be construed in accordance with the laws of the State of Illinois.
